- 1. Checklist for cancellation of the Remisier registration.
  - Cancellation letter addressed to the Membership Operations Department on the letter head of the Trading Member regarding cancellation of the Remisier
  - Discharge Certificate as per the prescribed format
  - Acknowledged copy of the cancellation letter sent to the Remisier
  - Original registration certificate of the Remisier. (In case the Original Registration letter of the remisier is misplaced/lost and the Trading Member wants to cancel the Remisier registration, then in such case the Trading Member will give a separate letter addressed to the Exchange on their letter head stating that the Original Remisiers Registration Letter is misplaced/lost.)

- 2. The processing fee will be charged will be Rs. 500/- per application for cancellation of the Remisiers registration and this processing fee will be debited to the Trading Member's General Charges account in the subsequent month.
- 3. No processing fee will be charged for cancellation due to death of the Remisiers.
